## Amplify International Enhanced Dividend Income ETF (IDVO)

### Notification of Source of Distributions

Pursuant to Rule 19a-1 under the Investment Company Act of 1940

In connection with the monthly dividend payment of \$0.1317 per share payable December 30, 2022 to shareholders of record on December 29, 2022, it is anticipated that 54% of such dividend will be a return of capital.
