

# SELECTION METHODOLOGY

MVPS harnesses the growth and transparency of thematic ETFs to establish a consensus view on which companies best align with popular investment themes based on publicly available ETF ownership data.

The initial universe is established by identifying all companies held by ETFs in a qualifying thematic universe.

- Disruptive Technology
- Evolving Consumer
- FinTech
- Health Care Innovation
- Industrial Revolution
- Sustainability
- Multi-Theme

Of the companies in this initial universe, an ownership consensus rating<sup>1</sup> for each eligible company is calculated. The Thematic All-Stars are determined as those companies in the top 75% of this ownership consensus rating.
