

## Amplify CWP Enhanced Dividend Income ETF (DIVO)

September 2022 Recap

[Amplify CWP Enhanced Dividend Income ETF \(DIVO\)](#) received a 5-star Morningstar Rating™ for the overall period based on risk-adjusted return among 79 funds in the Derivative Income category (as of 9/30/22). DIVO returned -6.82% on a net asset value (NAV) compared to its benchmarks, the S&P 500 TR Index at -9.21% and the CBOE S&P 500, BuyWrite Index at -6.57% as of September 30, 2022. For the month of September 2022, none of the sectors contributed positive returns with health care sector (avg. weight of 18%), communications services (avg. weight of 1%), and materials (avg. weight of 2%) impacting the least. The information technology (avg. weight of 17%) and industrials (avg. weight of 11%) detracted the most from DIVO's return during the period. Positions that contributed most significantly included Merck & Co, Inc. (portfolio avg weight of 5.29%) and Johnson & Johnson (portfolio avg weight of 5.72%). Positions that detracted most significantly included United Parcel Services (portfolio avg weight of 4.87%) and Goldman Sachs Group Inc (portfolio avg weight of 5.04%), respectively. The portfolio held six covered calls<sup>1</sup> at the end of September 2022, Dow Inc, General Mills, Marathon, Microsoft, and United Parcel.

A “buy-write” strategy is generally one in which an investor buys a stock (or basket of stocks), and also writes covered calls that correspond to those holdings.

DIVO differs substantially from the S&P 500 Index and Cboe S&P 500 BuyWrite index, which are used for comparison purposes as widely recognized measures of U.S. stock market performance. While the returns of DIVO have exhibited positive (but varying) correlation to the indexes over time, DIVO may invest in different stocks and in different proportions than in the S&P 500 index and Cboe BuyWrite index.

The weights are: 100% three-year rating for 36-59 months of total returns, 60% five-year rating/40% three-year rating for 60-119 months of total returns, and 50% 10-year rating/30% five-year rating/20% three-year rating for 120 or more months of total returns. While the 10-year overall star rating formula seems to give the most weight to the 10-year period, the most recent three-year period actually has the greatest impact because it is included in all three rating periods. DIVO received 5 stars among 79 funds in the Derivative Income category for the overall, 3-year, and 52 funds for the 5-year periods ending 9/30/22.*
