

[Amplify Natural Resources Dividend Income ETF \(NDIV\)](#) seeks investment results that generally correspond to the price and yield of the EQM Natural Resources Dividend Income Index. The Index is comprised of dividend-paying U.S. exchange-listed equities operating primarily in the natural resource and commodity-related industries such as: energy, chemicals, agriculture, metals & mining, paper products, and timber. NDIV returned 8.80% on a net asset value (NAV) compared to its benchmarks, the EQM Natural Resources Dividend Income Index at 8.74% for the month as of November 30, 2022. All the industries within the portfolio contributed to NDIV's return. Metals & mining (31.55%), contributed the most followed by oil, gas & consumable fuels (53.01%), chemicals (14.24%), and energy equipment & services (1.20%) respectively. Positions that contributed most significantly included BHP Group (4.53%) and Gerdau SA (3.51%). Positions that detracted most significantly included Devon Energy Corp (2.12%) and ICL Group LTD (3.23%), respectively.
