#### **RECAP**

Amplify Natural Resources Dividend Income ETF (NDIV) seeks investment results that generally correspond to the price and yield of the EQM Natural Resources Dividend Income Index. The Index is comprised of dividend-paying U.S. exchange-listed equities operating primarily in the natural resource and commodity-related industries such as: energy, chemicals, agriculture, metals & mining, paper products, and timber. NDIV returned -4.15% on a net asset value (NAV) compared to its benchmark, the EQM Natural Resources Dividend Income Index at -4.12% for the month as of December 31, 2022. The top contributing industry to the portfolio was energy equipment & services (1.27%). All the remaining industries within the portfolio detracted to NDIV's return. Oil, gas & consumable fuels (53.70%), detracted the most, followed by chemicals (12.42%) and metals & mining (32.59%), respectively. Positions that contributed most significantly included Ecopetrol (4.43%) and Rio Tinto PLC (3.41%). Positions that detracted most significantly included ICL Group LTD (3.02%) and Gerdau (3.37%), respectively.

### **YIELD**

Distribution Frequency: Monthly Distribution Rate: 9.13% 30-Day SEC Yield: 8.61%

**Distribution Rate** is the annual yield an investor would receive if the most recent distribution remained the same going forward. The yield represents a single distribution from the fund and does not represent total return to the fund. The distribution yield is calculated by annualizing the most recent distribution – from both dividend and option income – and dividing it by the most recent NAV. Distributions have included a return of capital. It is based on the most recent month end. This figure reflects the income earned from dividends – excluding option income – during the period after deducting the Fund's expenses for the period.
