Amplify CWP Enhanced Dividend Income ETF (DIVO) received a 5-star Morningstar Rating[™] for the overall period based on risk-adjusted return among 80 funds in the Derivative Income category (as of 01/31/23). DIVO returned 1.17% on a net asset value (NAV) compared to its benchmarks, the S&P 500 TR Index at 6.28% and the CBOE S&P 500 BuyWrite Index at 4.18% for month ending January 31, 2023. The information technology sector (13.66%) contributed most significantly to DIVO's return, followed by materials (5.46%) and financials (10.72%), respectively for the month of January 2023. Health care (22.69%) and consumer staples (9.50%) contributed the least to DIVO's return during the period, respectively. Positions that contributed most significantly included Nucor Corporation (3.41%) and Visa Inc. (5.23%). Positions that detracted most significantly included Johnson & Johnson (4.65%) and UnitedHealth Group Inc. (5.26%), respectively. The portfolio held four covered calls¹ at the end of January 2023: Microsoft Corporation, Apple Inc., and two in Merck & Co. Inc.

January 2023 Commentary

Exchange-traded funds and open-ended mutual funds are considered a single population for comparative purposes. It is calculated based on a Morningstar Risk-Adjusted Return measure that accounts for variation in a managed product's monthly excess performance, placing more emphasis on downward variations and rewarding consistent performance. The Morningstar Rating does not include any adjustment for sales loads. The top 10% of products in each product category receive 5 stars, the next 22.5% receive 4 stars, the next 35% receive 3 stars, the next 22.5% receive 2 stars, and the bottom 10% receive 1 star. The Overall Morningstar Rating for a managed product is derived from a weighted average of the performance figures associated with its three-, five-, and 10-year (if applicable) Morningstar Rating metrics. The weights are: 100% three-year rating for 36-59 months of total returns, 60% five-year rating/40% three-year rating for 60-119 months of total returns, and 50% 10-year rating/30% five-year rating/20% three-year rating for 120 or more months of total returns. While the 10-year overall star rating formula seems to give the most weight to the 10-year period, the most recent three-year period actually has the greatest impact because it is included in all three rating periods. DIVO received 5 stars among 80 funds in the Derivative Income category for the overall, 3-year, and 62 funds for the 5-year periods ending 01/31/23.
