RECAP

Amplify Natural Resources Dividend Income ETF (NDIV) seeks investment results that generally correspond to the price and yield of the EQM Natural Resources Dividend Income Index. The Index is comprised of dividend-paying U.S. exchange-listed equities operating primarily in the natural resource and commodity-related industries such as: energy, chemicals, agriculture, metals & mining, paper products, and timber. NDIV returned 8.45% on a net asset value (NAV) compared to its benchmark, the EQM Natural Resources Dividend Income Index at 8.53% for the month, as of January 31, 2023. The top contributing industry to the portfolio was metals & mining (19.20%) followed by oil, gas & consumable fuels (68.67%) and chemicals (12.13%). There were no industry detractors. Positions that contributed most significantly included BHP Group LTD (4.66%) Ecopetrol SA (security no longer held in portfolio as of 1/31/2023) and Ternium SA (0.82%). Positions that detracted most significantly included Chesapeake Energy Corp (6.09%) and Chord Energy Corp (4.89%), respectively.
