RECAP

[Amplify Natural Resources Dividend Income ETF \(NDIV\)](#) seeks investment results that generally correspond to the price and yield of the EQM Natural Resources Dividend Income Index. The Index is comprised of dividend-paying U.S. exchange-listed equities operating primarily in the natural resource and commodity-related industries such as: energy, chemicals, agriculture, metals & mining, paper products, and timber. NDIV returned -1.04% on a net asset value (NAV) compared to its benchmark, the EQM Natural Resources Dividend Income Index at -0.93% for the month, as of March 31, 2023. The metals & mining industry (18.06%) contributed most significantly to NDIV's return for the month of March 2023. The following industries detracted from the portfolio: chemicals (11.61%) and oil, gas & consumable fuels (70.32%). Positions that contributed most significantly included BHP Group Ltd. (4.70%), Pioneer Natural Resources Co. (4.19%), and Hess Midstream (3.39%). Positions that detracted most significantly included Petroleo Brasileiro (7.36%) and Sociedad Quimica Y Minera (4.33%), respectively.
