## RECAP

Amplify CWP Enhanced Dividend Income ETF (DIVO) received a 5-star Morningstar Rating<sup>™</sup> for the overall period based on risk-adjusted return among 82 funds in the Derivative Income category (as of 05/31/23). DIVO returned - 4.04% on a net asset value (NAV) compared to its benchmarks, the S&P 500 TR Index at 0.43% and the CBOE S&P 500 BuyWrite Index at 0.96% for month ending May 31, 2023. The information technology sector (11.60%) contributed most significantly to DIVO's return for the month of May 2023. Energy (11.18%) and consumer staples (13.22%) contributed the least to DIVO's return during the period, respectively. Positions that contributed most significantly included Microsoft Corp. (5.51%) and Apple Inc. (4.41%). Positions that detracted most significantly included Chevron Corp. (5.01%) and Procter and Gamble Co. (5.10%), respectively. The portfolio held one covered calls<sup>1</sup> at the end of May 2023: Microsoft Corp.
