### **RECAP**

Amplify Natural Resources Dividend Income ETF (NDIV) seeks investment results that generally correspond to the price and yield of the EQM Natural Resources Dividend Income Index. The Index is comprised of dividend-paying U.S. exchange-listed equities operating primarily in the natural resource and commodity-related industries such as: energy, chemicals, agriculture, metals & mining, paper products, and timber. NDIV returned -5.93% on a net asset value (NAV) compared to its benchmark, the EQM Natural Resources Dividend Income Index at -5.84% for the month, as of May 31, 2023. The paper & forest products (1.57%) contributed most significantly to NDIV's return for the month of May 2023. The following industries detracted from the portfolio: oil, gas, and consumable fuels (76.49%), chemicals (13.52%) and metals & mining (8.42%). Positions that contributed most significantly included Petroleo Brasileiro (5.39%), Kinetik Holdings Inc. (3.60%), and Suzano (1.56%). Positions that detracted most significantly included Equinor (2.86%) and Devon Energy Corp. (1.93%), respectively.

## **YIELD**

**Distribution Rate** is the annual yield an investor would receive if the most recent distribution remained the same going forward. The yield represents a single distribution from the fund and does not represent total return to the fund.
