## RECAP

[Amplify Natural Resources Dividend Income ETF \(NDIV\)](#) seeks investment results that generally correspond to the price and yield of the EQM Natural Resources Dividend Income Index. The Index is comprised of dividend-paying U.S. exchange-listed equities operating primarily in the natural resource and commodity-related industries such as: energy, chemicals, agriculture, metals & mining, paper products, and timber. NDIV returned 6.57% on a net asset value (NAV) compared to its benchmark, the EQM Natural Resources Dividend Income Index at 6.67% for the month, as of July 31, 2023. The oil, gas, and consumable fuels (78.66%) contributed most significantly to NDIV's return for the month of July 2023, followed by chemicals (11.18%), and metals & mining (8.80%). There were no industry detractors. Positions that contributed most significantly included ICL Group Ltd. (2.84%), Ternium SA (security no longer held in the portfolio as of 7/31/2023), and Ecopetrol SA (3.04%). Positions that detracted most significantly included TC Energy Corp. (2.48%) and Enbridge Inc. (2.62%).
