Amplify Natural Resources Dividend Income ETF (NDIV) seeks investment results that generally correspond to the price and yield of the EQM Natural Resources Dividend Income Index. The Index is comprised of dividend-paying U.S. exchange-listed equities operating primarily in the natural resource and commodity-related industries such as: energy, chemicals, agriculture, metals & mining, paper products, and timber. NDIV returned -0.02% on a net asset value (NAV) compared to its benchmark, the EQM Natural Resources Dividend Income Index at 0.06% for the month, as of August 31, 2023. The oil, gas, and consumable fuels (+1.72%) contributed most significantly to NDIV's return for the month of August 2023. The following industries detracted from the portfolio: electrical equipment (-15.06%) and metals & mining (-7.02%).¹ Positions that contributed most significantly included Permian Resources (PR), Civitas Resources (CIVI), and Suncor Energy (SU). Positions that detracted most significantly included Sociedad Quimica Y Minera (SQM) and Anglo American (NGLOY).
