### **RECAP**

Amplify Natural Resources Dividend Income ETF (NDIV) seeks investment results that generally correspond to the price and yield of the EQM Natural Resources Dividend Income Index. The Index is comprised of dividend-paying U.S. exchange-listed equities operating primarily in the natural resource and commodity-related industries such as: energy, chemicals, agriculture, metals & mining, paper products, and timber. NDIV returned -0.31% on a net asset value (NAV) compared to its benchmark, the EQM Natural Resources Dividend Income Index at -0.26% for the month, as of September 30, 2023. The oil, gas, and consumable fuels (+0.88%) contributed most significantly to NDIV's return for the month of September 2023. The following industries detracted from the portfolio: chemicals (-6.38%), electrical equipment (-4.67%) and metals & mining (-1.86%).¹ Positions that contributed most significantly included Imperial Oil (IMO), Valero Energy (VLO) and Equinor ASA (EQNR). Positions that detracted most significantly included Huntsman (HUN), Eastman Chemical (EMN) and ICL Group (ICL).

# **YIELD**

**Distribution Rate** is the annual yield an investor would receive if the most recent distribution remained the same going forward.
