Amplify Natural Resources Dividend Income ETF (NDIV) seeks investment results that generally correspond to the price and yield of the EQM Natural Resources Dividend Income Index. The Index is comprised of dividend-paying U.S. exchange-listed equities operating primarily in the natural resource and commodity-related industries such as: energy, chemicals, agriculture, metals & mining, paper products, and timber. NDIV returned 4.57% on a net asset value (NAV) compared to its benchmark, the EQM Natural Resources Dividend Income Index at 4.91% for the month, as of November 30, 2023. Energy equipment & services (+11.98%) and metals & mining (+7.27%) contributed the most to the Fund's return for the month.¹ Positions that contributed most significantly included Agnico Eagle Mines (AEM), Phillips 66 (PSX) and Eastman Chemical (EMN). Positions that detracted most significantly included Civitas Resources (CIVI), Sitio Royalties (STR) and HF Sinclair (DINO).
