Notification of Source of Distributions

In connection with the monthly dividend payment of \$0.2104 per share payable on March 31, 2025 to shareholders of record on March 28, 2025, it is anticipated that 93% of such dividend will be a return of capital.

The amounts and sources of distributions reported in this notice are estimates on a book basis, are not being provided for tax reporting purposes and may later be determined to be from taxable net investment income, short-term gains, long-term gains (to the extent permitted by law), and return of capital.
