In connection with the monthly dividend payment of \$0.2368 per share payable on March 31, 2025 to shareholders of record on March 28, 2025, it is anticipated that 75% of such dividend will be a return of capital.

The Fund will send you a Form 1099-DIV for the calendar year that will tell you how to report these distributions for federal income tax purposes.
