## Amplify Bitcoin 2% Monthly Option Income ETF (BITY)

### Notification of Source of Distributions

In connection with the monthly dividend payment of \$0.6948 per share payable on March 31, 2026 to shareholders of record on March 30, 2026, it is anticipated that 97% of such dividend will be a return of capital.
