## Amplify Bloomberg U.S. Treasury 12% Premium Income ETF (TLTP)

Notification of Source of Distributions

In connection with the monthly dividend payment of \$0.2329 per share payable on April 30, 2025 to shareholders of record on April 29, 2025, it is anticipated that 66% of such dividend will be a return of capital.
