

## Amplify Bitcoin Max Income Covered Call ETF (BAGY)

Notification of Source of Distributions

In connection with the monthly dividend payment of \$1.4613 per share payable on May 30, 2025 to shareholders of record on May 29, 2025, it is anticipated that 96% of such dividend will be a return of capital.
