Notification of Source of Distributions

Pursuant to Rule 19a-1 under the Investment Company Act of 1940

In connection with the monthly dividend payment of \$0.1893 per share payable on June 30, 2025 to shareholders of record on June 27, 2025, it is anticipated that 74% of such dividend will be a return of capital.
