## Amplify CWP Enhanced Dividend Income ETF (DIVO)

### Notification of Source of Distributions

Pursuant to Rule 19a-1 under the Investment Company Act of 1940

In connection with the monthly dividend payment of \$0.1429 per share payable August 31, 2023 to shareholders of record on August 30, 2023, it is anticipated that 49% of such dividend will be a return of capital.

The Fund will send you a Form 1099-DIV for the calendar year that will tell you how to report these distributions for federal income tax purposes. **As a result, shareholders should not use the information provided in this notice for tax reporting purposes.**
