

## **Amplify Ethereum Max Income Covered Call ETF (EHY)**

Notification of Source of Distributions

In connection with the monthly dividend payment of \$0.7496 per share payable on November 28, 2025 to shareholders of record on November 26, 2025, it is anticipated that 95% of such dividend will be a return of capital.
